Meeting called to order by: Jamison Smith @ 1805

• Approval of January minutes without corrections:

Motion made by Jamison Smith to approve the January minutes, 2<sup>nd</sup> by Henry Simpson. All in attendance were in favor. Motion carried.

Presidents opening statements (addressed by Jamison Smith in the absence of the president):

Motion made by Jamison Smith to amend the rule 5.01a to remove the phrase "10 run rule" and replace with "Games are considered official and will be called once the conditions of rule 4.10 e have been met. The rule will now be "15 runs after the 3<sup>rd</sup> inning, 10 runs after the 4<sup>th</sup> inning, and 8 runs after the 5<sup>th</sup> inning" to serve as the "mercy rule". 2<sup>nd</sup> by Henry Simpson. All in attendance were in favor. Motion carried.

- The last meeting was January 30<sup>th</sup> with the following meeting scheduled for February 13<sup>th</sup>.

  Minutes were sent out on February 11<sup>th</sup>. Richie requested minutes to be sent out sooner.
- March 4<sup>th</sup> draft times will be posted, they will start at 9am with the last group at 130pm.
- ➤ The coaches committee meeting has selected managers. Jamison presented on the whiteboard and motioned to approve the names presented. David Denniston 2<sup>nd</sup>. None in attendance were opposed. Motion carried.
- Background checks need to be completed.
- ➤ Jamison made a motion to waive Jr. BB and SB for late fees, same as Sr. BB and SB. 2<sup>nd</sup> by Jessica Jackson. All in attendance were in favor. Motion carried.
- Vice President Report: Blended with Presidents reports

- Treasures Report: No new reports since last meeting 2 weeks ago. Mandy will have updated monthly report at next meeting
- Safety Officer Report: Joe Davenport states safety plan has been submitted and approved.

T-ball is still trying to recruit managers. Reminded everyone that there is no drafting for T-ball or Blast-ball. David Denniston made a motion to amend rule 3.10a to allow managers to pick assistant managers for T-ball and Blast-ball only. 2<sup>nd</sup> by Jamison Smith. All in attendance were in favor. Motion carried.
- BB Coach and Player Development report: Henry Simpson states assessments are scheduled for Feb. 18<sup>th</sup>. There will be a mandatory managers meeting on February 25<sup>th</sup> 6-8pm. Would like to work with Jenae to provide a feedback type forum on the website for umpires or a "coaches corner"
- Player Agent Report: Jessica Jackson reports that she and Jessica Attkisson will be present to help organize assessments on Feb. 18<sup>th</sup>. She will send out a schedule. Jessica Attkission states blastball registration is still open and is hoping for a few more to register.
- Umpire-in-Chief Report: Nothing to report
- **Fields and Grounds Director Report:** Shawn Divelbliss states the board will need to work most weekend from now until the start of season to prepare the park. He will post a "to do" list on the whiteboard in the meeting room, as well as on whatsapp and is requesting anyone with the time and ability to complete these tasks to do so.

- Fundraising Manager Report: Crystal Voynow states there will be a team rep meeting on March 18<sup>th</sup>. All teams will need a representative to attend. She will work on a responsibility checklist for the coaches to provide to the parent that volunteers for this position.

Shawn Divelbliss requested a motion be made on rule 5.2d regarding the draft order that if

there are 2 teams to be drafted it will be by alternate picking and if there are more than 2

teams it will be a snake draft and determined from a hat draw for picking order. Jamison made

the motion, 2<sup>nd</sup> by Jessica Jackson. All in attendance were in favor. Motion carried.

Shawn Divelbliss made a motion to move the protected players (managers' children) from the

top of the draft list to the bottom. 2<sup>nd</sup> by Joe Davenport. 6 were in favor and 7 opposed from

those that voted. Motion was 7 – 6 against. Motion failed.
