Commissioners' Report:

- Baseball

 - Elite may come to October mtg to discuss field use (currently discussing possibility of exchanging field time at Carpenter Park for field time at Elite)
- Softball

 - We will place chain across Softball field to prevent vehicles from damaging the field
- Soccer
 - Teams were well prepared after summer skills camp. Recommendation

- to do it again next year
- Coach's meeting after skills camp was helpful.

- 9/13- Soccer photos were completed. Working with Photos by Chip has been successful. Links for ordering will be sent in next couple of weeks
- Lining fields is going well- volunteers are scheduled for the rest of the season
 - Need to reassess paint needs
- Working through some ref shortages in September
 - Refs for U10 Tournament are secured, may add some younger refs to supplement
 - Working with Pembroke Academy to set up community service for refs
- End of Season Celebration
 - U4,U6 and U8- earlier breakfast celebration
 - U10 and U12 later in season
 - Terri made a motion to buy CYA Winter hats for end of season gifts, seconded by Maryellen Fish, with all members in favor
- Chelsea spoke with parent regarding Code of Conduct violation during practice in U8. The athlete has decided not to continue playing soccer.
 - Plan to create code of conduct violation form and share at coach's meeting next year
 - The commission team will check in with coaches regarding behavior and parent's supervision.
