Discussion Topics

President Report (Brielle)

- All Stars 2025
 - Re-do/add Championship Banners
 - Brielle got a quote: \$275 for all three banners
 - Kevin made a motion to purchase banners; Jenn seconded the motion; passed unanimously
 - Budget for All Star teams that win district tournament
 - Discussed cost for team families when they move past district to state tournament
 - Kevin made a motion to add a line item in the annual budget of \$3,000.00 for All Stars state tournament expenses, including an addition of \$300-\$500 per year to fund; Ed seconded the motion; passed unanimously
 - D13 is Hosting 10U State Tournament Next Year at Tempe Sports Complex
 - Every little league in D13 must contribute an additional \$650.00 to the district; that amount may change based on sponsorships
 - Brielle made a motion to add \$650.00 to the annual budget to accommodate this expense; Jenn seconded the motion; passed unanimously
- Good Sports Grant
 - Brielle secured a grant that allows TSLL to place 8 orders per year for equipment: bats, baseballs, uniforms, cleats
 - TSLL must pay for shipping only



Fall Ball Report (Mike and Kevin)

- Fall Calendar
 - Rio, Guadalupe, and Chandler little leagues will not participate; registration could open to individual participants to ensure full teams
 - 4 teams per level (52 kids per level); 12-13 kids per team
 - Majors and Minors teams will play 8 games (MWF 7:30 PM)
 - AAA teams will play 6 games (T/Th 5:30 PM)
 - AA teams will play 6 games (T/Th 5:30 PM)
 - TBall will play 6 games (MW 5:30 PM)
 - Mantai field will be available for practices
- Fall ball intention is developmental
- Registration goes live 8/15; TSLL kids take registration priority over out of boundary players (regardless of registration date)
- Mental Strength Course
 - Warrior Athlete mental performance training by Mike Budak
 - 9 weeks; 1x/week group call
 - Example lessons: goal setting/handling mistakes and failure
 - Add on \$100/registration for minors and majors athletes (\$50 revenue for TSLL per registration)
- 8/15 Fundraiser/Kick Off event/Raffle at Hit Squad Ninja Gym
 - \$35/family, pizza and admission, raffles, 50% revenue back to TSLL
- Hit Dog Sponsorship and Camps (revenue for TSLL)
- Five Tool Sponsorship and Camp (revenue for TSLL)
 - Uniform sponsorship \$2,000.00; will host clinic with kickback to TSLL
- SCHEELS sponsorship
 - Was a one year sponsorship
 - Logo will be on uniform this fall and agreement ends mid January 2026
- Jr. Program/Coach
 - Lucas inquired via email about Juniors fall ball team
 - Wait and see for registration

- Brielle put together donation for up to \$500.00 gift card for TSLL

Fundraising Report (Robyn)

- Online store for fall "back to baseball" items
- Purchases at wholesale, will get 50% back
- Uniform vendor was used for All Stars uniforms

- Ian Freeman will lead umpire training at start of fall ball 9/20 - 9-11 AM; pay umpires \$20 for coming
- Adults and youth can umpire for fall ball; Brielle will post umpire call in newsletter and social media

Spring Calendar Draft (Kevin)

- Kevin presented spring 2026 calendar
- Predict 6 majors teams, 8 minors teams, lower levels at 12 kids/team
- 16, 14, 12, 10, 8 games in each division
- Will use orange first bases
- Talked about calendar and why we have opening day 2/28 (before spring break) rather than after spring break
