Discussion Topics

President Report (Brielle)

- Review TSLL Bylaws
 - Jenn made a motion to change eligibility for voting from “4 of the 6 previous meetings” to “5 of the previous 9 meetings”; Lucas Landreth seconded the motion; passed unanimously
 - All board members are encouraged to review the bylaws and propose changes at the October meeting
- 2026 Board Elections (Brielle)
 - Eligible participants are encouraged to decide if and what position they want to run for in 2026
 - Elections are in November
 - There are lots of volunteer board positions available in addition to executive (elected) board positions
