



## Out-of-Boundary Waiver

### What is Needed

- **Statement from player's family**
  - Reason for request
- **Approval or denial from home league**
  - If denied, the league must give a reason
- **Approval or denial from requested league**
  - If denied, the league must give a reason
- **Recommendation from District Administrator**
  - Pick one of the below options
    - Full eligibility
    - Red-Shirt (regular season only for 2022. Tournament eligible starting in 2023)
    - Deny
  - Any other important information regarding this request
- **Player information**
  1. Player's name
  2. Player's home address
  3. Player's age
  4. Where the player has been previously participating
    - If player has been participating in the requested league, was a residency waiver completed?

**Once all information has been gathered by the DA, please send to Andrew Cortez or Jake Gallaway by Friday**

### Committee Decision

- **The player's request will be presented to the International Charter Committee**
  - Typically meet on Wednesday
- **The committee will respond with the following:**
  - **Full eligibility**
  - **Red-Shirt**
  - **Deny**
  - **Needs more information**
    - Case will still be open. Andrew or Jake will reach out to the DA
- **The committee's decision is final**
- **If a player is granted a waiver from the committee, they do not need to apply again in the future**
  - This waiver will stay with the player for the duration of their career
- **A formal response will be sent to the DA on Friday**
  - Please make sure the League President and DA keep a copy
