- 1. I hereby acknowledge & understand that said surfaces may be regular or very irregular.
- 2. INTENT TO INFORM: I acknowledge that I am fully aware of the potential dangers of participation in any sport. I fully understand that participation in football, cheerleading and/or dance may result in SERIOUS INJURIES, PARALYSIS, PERMANENT DISABILITY AND/OR DEATH. I fully acknowledge & understand that protective equipment does not prevent all participant injuries, & I do hereby waive, release, absolve, indemnify, & agree to hold harmless the coaches, local, league and The Naples Gators organization. Any and all organizers, sponsors, supervisors, participants, & persons transporting the above named participant to and from activities, from any claim arising out of any injury to my/our child whether the result of negligence or for any other cause.
- **3. EMERGENCY MEDICAL AUTHORIZATION:** I hereby grant my permission for any and all emergency medical/dental treatment and/or first aid to be administered to my child/participant, including authorizing any medical treatment facility/hospital to administer emergency treatment, for any illness/injury/accident resulting from participation in any and all Naples Gators activities.
- **4. EQUIPMENT RESPONSIBILITY:** I agree to assume full responsibility for any and all equipment/uniforms loaned to the above named participant and I agree to promptly return, upon request, the uniform and other equipment issued to the above named participant in as good condition as when received except for normal wear and tear. If I fail to adhere to this policy, I will be responsible for the full replacement cost of such equipment.
- 5. INSURANCE DISCLOSURE: I am aware that the Naples Gators organization carries group accident insurance which is considered secondary or excess for medical purposes to any and all valid insurance I possess is considered primary insurance. I agree to notify in writing my head coach & the Naples Gators organization of any medical claim as a result of participation. I understand that any registration fee paid does not constitute a direct premium for insurance and that a deductible(s) may apply.
- **6. SCHOLASTIC VERIFICATION:** I hereby stipulate that either my child is scholastically fit, or that I have completed the scholastic eligibility form or the Home School Eligibility Form and will adhere to all rules and regulations therein. Furthermore, I hereby authorize my child's school to release school grades, report card results, and any and all other pertinent scholastic information to the local Pop Warner organization in order to comply with the Naples Gators scholastic fitness requirements
- 7. FINANCIAL RESPONSIBILITY: I hereby stipulate that I have been advised by the Naples Gators organization of my rights. Season payment is due before the players first day of practice. There will be no refunds for the Spring 2026 Season.
- 8. COMMUNICATION AND PROMOTIONAL CONSENT: As a condition to my child's participation, I hereby consent to receive communications via email and mail from the Naples Gators organization. I understand that the Naples Gators organization does not sell its contact lists and communications sent may contain program information as well as special offers and may be opted out of by following the instructions in the email or via written request to the Naples Gators. I hereby grant the Naples Gators organization the absolute right and permission to make, reproduce, broadcast or otherwise use participant's name and likeness, any photograph, films, videos, recordings, or other depictions or images in whatever form or media in connection with participation in the Naples Gators organization throughout the universe in perpetuity and in any and all advertising and promotion materials, in any manner or media whatsoever for purposes of art, advertising, editorial, trade or promotion or any other purpose whatsoever. To the extent that any benefit accrues or may accrue to the Naples Gators organization, I hereby and forever waive any interest in or claim to such benefits and acknowledge that the Naples Gators is under no obligation to exercise any rights granted herein.
- 9. ADULT CODE OF CONDUCT: S1: In order to uphold the goals of the Naples Gators and ensure that all participants have the benefit of a safe and fun learning environment, all parents, guardians and other adults and attendees of the Naples Gators events, including but not limited to practices, competitions, and banquets, must behave accordingly in a respectful, courteous and sportsmanlike manner at all times. S2: Any adult who is using alcohol, tobacco or non-prescription drugs and/or appears intoxicated at a the Naples Gators event, and/or who is flagrantly rude, attempts to intimidate, verbally abuse, heckles, taunts, ridicules, boos, throws objects and/or uses vulgarity or profane language/gestures with an official, coach, volunteer, staff member, participant or other event attendee, must receive a verbal warning and/or be asked to leave a the event. The member organization may also provide a written warning to the individual regarding the misbehavior. The adult's children may also be removed from the event. Any adult who commits one of the above stated offenses a second time, will be banned from any and all Naples Gators events for a period of one year from the date of the second offense, and their children may also be removed from the program(s) for that time period. S3: Any adult who physically assaults an official, coach, volunteer, staff member or participant or threatens grave bodily harm may be banned from any and all Naples Gators events for one year from the date of the offense, and their children may also be removed from any and all Naples Gators events for one year from the date of the offense, and their children may also be removed from any and all Naples Gators events and the individual commits another offense of the adult code of conduct, the individual will be permanently banned from any and all Naples Gators events and the individual's children may also be permanently removed as well.
- 10. I/We hereby hold the Naples Gators harmless of any financial loss as the result of any disciplinary action.

DISPUTE RESOLUTION POLICY SEVERABILITY: I hereby understand and acknowledge that all civil disputes between Naples Gators and any and all affiliated parties will be subject to binding arbitration in the locale laws under the guidelines and rules of the American Arbitration Association. I hereby agree that this binding arbitration shall be in lieu of any litigation by and between myself, Gators, and any and all affiliated parties. I also understand and agree that if I contest any decision or ruling of Naples Gators and seek other recourse, that I will reimburse Naples Gators for all legal fees and expenses it reasonably incurs. If any portion of this form shall be deemed unenforceable, illegal, and/or invalid, the reminder shall remain in full force and effect.
