Player Code of Conduct Violation

- A player on a Majors team has been breaking the players code of conduct.
- She has been swearing.
- The player will be given this one warning, that she will receive at the next game or practice.

- If violated again disciplinary action will follow.
- Board needs to put a policy in place regarding breaking the code of conduct and use this model in any future instances.

Parent/Player Conduct Policy

- This model should be clear and enforced with a zero tolerance policy.
- The new policy regarding parent/player conduct is:
- First offense is a verbal warning. There will be only 1 warning.
- Second offense will result in a one-game suspension.
- Third offense and the offender is banned.

Code of Conduct Review

- Board needs to verify the verbiage of the disciplinary action in place for code of conduct offenses.
- Once the board decides on verbiage for consequences, it will be added to the current code of conduct that all players and parents sign.

Jersey Vendor Selection

- Need to find a new vendor.
- Possibly "League Outfitters"
- Currently paying \$30 per jersey.
- Possibly offer a long contract in return for a percentage of sales being returned to the league.

vendors and address at the next meeting.

All-Star Game Discussion

Fall Ball Registration

- Flyers will be sent out at the end of May before school is dismissed for the summer.

- Board discussed raising the price of Majors and Minors and keeping Coach

pitch the same.

- New price for majors and minors will be \$150 and Coach Pitch will stay at \$125.
