- b. VP of Baseball Operations, Alfonso Cordero, will review NWS Digital Forecast Map in the morning of all scheduled activities

 - g. If conditions require cancellations - BMOD will inform the home plate umpire, coordinate safe field clearing, & ensure play does not resume until conditions meet safety requirements
 - h. Communications Coordinator & Social Media Manager will post timely updates when requested by VPBO or BMOD
