## Wording for SGR

**IMPORTANT RULE CLARIFICATION Concerning: ALL DIVISIONS Because the CA State requirements for** Livescan, the board has implemented a policy regarding non-rostered coaches. If a manager has a non-rostered coach on the field at any time, GAME or PRACTICE, the manager faces a 1-game suspension. If this happens a second time, the manager will be removed as a manager for their team. If you find that you do not have enough rostered coaches to conduct your game, please reach out to Chalet Kukahiko (NLL.VP.Adminsitration@norcolittleleague.com) and she will approve an up to date live scanned volunteer to assist you during the game. You MAY NOT approve a substitute coach without getting board approval from Chalet, even if the volunteer is livescanned to your knowledge.
