

# West Terre Haute Little League Travel Ball Agreement

This agreement outlines expectations, responsibilities, and shared use of facilities.

## Travel Ball Agreement

Between West Terre Haute Little League (WTHLL) and [Travel Team Name]

### 1. Purpose

This agreement establishes a mutual understanding between WTHLL and [Travel Team Name] regarding shared use of facilities, coordination of schedules, and responsibilities for maintenance.

### 2. Parties

- **West Terre Haute Little League (WTHLL)**  
A local youth baseball and softball organization committed to player development and community engagement.
- **[Travel Team Name]**  
A youth travel baseball organization seeking to use WTHLL facilities for practices and/or games.

---

### 3. Facility Use

- The Travel Team may use WTHLL fields **for a two-hour window** based on field availability and West Terre Haute Little League priority.
- WTHLL retains priority scheduling for all Little League regular season games, practices, and events.

- The Travel Team must coordinate with the WTHLL Facilities Coordinator and/or President for scheduling.
- All field use must be approved in advance.

---

#### 4. Fees

- Travel Team agrees to pay WTHLL a facility use fee of **\$5 per player per practice**.
- Price per player per practice is waived if player is a registered West Terre Haute Little League Spring Rec Player at West Terre Haute Little League. (Fall Ball is excluded)
- **Fees are due by Sunday of each week** via the WTHLL PayPal or by check. Make checks payable to West Terre Haute Little League. Note: The Sunday **AFTER** a team uses the field.
- If responsibilities (i.e. 5) are not completed, then price per player, regardless of WTHLL Rec league status, will be owed.

## 5. Responsibilities

### WTHLL Agrees To:

- Maintain field conditions suitable for youth baseball/softball.
- Provide access to restrooms (must be cleaned and trash taken out prior to leaving).
- Field lighting (may be provided at an additional hourly rate of \$20 and must be discussed prior to the practice time)
- Access to field rakes and hand drag for field maintenance.

### The Travel Team Agrees To:

- Leave facilities in equal or better condition than found.
- Clean up all trash and debris after use.
  - Empty trash can in dumpster
- Follow all WTHLL field rules and safety protocols.
- Provide proof of liability insurance listing WTHLL as additionally insured.
- Supervise all players and spectators during use.

---

## 6. Insurance & Liability

- The Travel Team must carry liability insurance of at least **\$1,000,000** per occurrence.
- WTHLL is not liable for injuries or damages occurring during Travel Team activities.
- Travel Team assumes full responsibility for participants and attendees.

---

## 7. Termination

- Either party may terminate this agreement with [e.g., 30 days] written notice.
  - Immediate termination may occur for serious violations of policy or behavior.
