Important events since previous board meeting

March 23rd: Executive Board Meeting held

March 26th, 2025, 24/25 season a club sponsor sent emails and personal text messages to the board and board members demanding the President step down. Sponsor was not happy with the direction the club heading was demanding changes be made. HSC board decided to discontinue the sponsorship for the 2026 season.

At the end of March and early April 2025, series of anonymous, threatening emails were sent by "anyonebutcooper" to Harbor Soccer Club (HSC), Washington Youth Soccer (WYS), and Recreational League (RCL) officials claiming that HSC failed to properly investigate an incident involving Eastside FC and included personal attacks on the HSC President.

- •The anonymous email was sent from what appeared to be the HSC domain and was reported to the FBI as hacking.
- •HSC met with WYS officials and legal representatives to discuss the anonymous emails and allegations.
- •WYS reviewed the claim and confirmed that HSC performed its due diligence and was cleared of wrongdoing.
- •WYS responded directly to the anonymous email stating that any complaint needed to be formally filed with a name attached for proper investigation.

No further emails were sent by the anonymous party after this date.
