\*In case of emergency I/We authorize the above named participant to be treated if necessary in the event that I/We are not available at the time of injury. I/We do consent for my/our child to be treated by an available physician, emergency response team, medical staff personnel authorized by Woodbury Midget Football Assoc., and any of its member teams.

\*I/We agree to pay all associated fees to the Woodbury Midget Football Assoc. Before the above named child will be able to receive any equipment that will be needed to participate in any football/cheerleading activities.

Please be aware that there will be a \$35 returned check fee charged on any check that is returned to the Woodbury Midget Football Association.

I acknowledge that if I fail to return the equipment described or if the equipment is damaged (except what is deemed by WMF as normal wear and tear), that I shall be responsible to pay for the replacement cost of the equipment borrowed. For any helmet not returned back to the organization at the end of the season it will be considered as stolen property and we will file a report with the local police department and parents will be obligated to pay the cost of \$200 to replace the helmet.**
