Sponsorship:

- Discussion on how and when to apply sponsorships if after certain dates
 - Jeanie mentioned, she would like to see it applied as we get them
 - Jeremy mentioned going forward there should be set dates, so families know costs, still accepting sponsorships after the given dated, but goes to capital campaign.

Decision: Sponsorships will apply as we get them in right now, but going forward a cutoff date and then goes towards capital campaign.

Benevity:

- In the past, these have not been applied like sponsorships for players/families
 - Jeremy mentioned if there are no rules from the companies that it can't go to individuals, then we should apply as we do sponsorships.
