



# La Pine Sports Academy (LPSA) Liability Waiver, Assumption of Risk & Policy Agreement

## Required for Participation

By registering a participant in any La Pine Sports Academy (LPSA) program, the parent/guardian (or participant if 18+) acknowledges and agrees to the following:

---

## Assumption of Risk

Participation in youth sports involves inherent risks, including but not limited to:

- Physical injury (sprains, fractures, concussions)
- Contact with other participants, equipment, or surfaces
- Environmental conditions (weather, heat, cold, smoke, air quality)
- Travel to and from practices, games, and events

I understand and voluntarily accept all risks associated with participation in LPSA programs.

## Release of Liability

I hereby release, waive, and discharge La Pine Sports Academy (LPSA), its board members, coaches, volunteers, sponsors, field owners, and affiliates from any and all liability, claims, demands, or causes of action arising out of or related to:

- Injury, illness, or damage sustained during participation
- Activities occurring at practices, games, events, or travel to/from such activities

This release applies to any and all claims, including those arising from negligence, to the fullest extent permitted by law.

## **Medical Authorization**

In the event of injury or medical emergency:

- I authorize LPSA staff, coaches, or volunteers to seek emergency medical treatment for my child
  - I understand that I am financially responsible for any medical care provided
- 

## **Insurance Acknowledgment**

I understand that:

- LPSA may carry limited insurance coverage
  - Any such coverage is secondary to my personal health insurance
  - I am responsible for maintaining adequate medical insurance for my child
- 

## **Concussion & Injury Responsibility**

I agree that:

- My child will follow all return-to-play guidelines
  - My child will not participate while injured or exhibiting symptoms of concussion
  - I will provide medical clearance when required
- 

## **Code of Conduct & Removal**

I understand that:

- LPSA reserves the right to remove any participant or parent for unsafe behavior, misconduct, or violation of league rules
  - Removal from a program does not guarantee a refund

## **Transportation Disclaimer**

I acknowledge that:

- LPSA does not provide transportation
  - I am responsible for transportation to and from all activities
  - Carpooling or third-party transportation is at my own risk
- 

## **Photo & Media Release**

I grant LPSA permission to use photos or videos of my child for promotional purposes, including website, social media, and marketing materials. No compensation will be provided.
