

#### **CENTERVILLE WEE ELKS GAMEDAY OPERATIONS PLAN**

## Game entry

- Entrance to games on either the north or the south field will be the main gate (west side of the venue). Seating capacity at the south field is at least 244 spectators, and north field at least 220 spectators. Bleacher seating will be limited due to social distancing requirements so please bring chairs.
- Each spectator will be allowed 2 tickets per household (this does not include members of the coaching/cheer staff or volunteers). Children 6 and under do not require a ticket.
- Spectators will form a line down the west sidewalk maintaining 6ft social distancing. They will be completing assessments and volunteers will be marking off which player you are attending for. Once a player/cheerleader has 2 tickets marked off under his/her name, no further spectators can enter under their name (except children under 6).
- Parents will drop their cheerleader or football player off behind the restrooms near the practice fields for warm-ups.
- QR codes will be used at the gates for symptom assessment purposes. In the event a spectator cannot complete this electronically, paper assessments will be utilized and kept on file.
- There will be minimal bleacher seating. Variance seating will be available in the open/grassy areas surrounding each field. Boxes will be marked in these open areas for 2 chairs. Should a spectator have 2 adults and enough children that they do not fit into the box, they may be asked to leave the venue if no other seating is available. Larger families should plan for alternate options for multiple children if they do not fit on the lap of either of the ticketed adults.

# Player requirements

- All players will complete an assessment and a temperature check prior to warm-ups. Any player
  with symptoms per CDC guidelines will be excluded from playing for that day. Information will
  be given on COVID-19 testing site(s) for those with symptoms. Signs will be posted for visiting
  and home team check-ins.
- Any player exhibiting symptoms of COVID-19 will not be allowed to play and will be asked to
  leave the venue. In the event this departure is delayed, a quarantine room to the north end of
  the south field will be utilized.

# **Restroom facilities**

- Restrooms right outside the main gate will be open and only 2 allowed inside at one time. There will be one entrance and one exit designated by signage.
- Spectators may exit the venue to use the restrooms, but the entrance gate will close once there are 2 minutes left in a game.



## Social Distancing and Hygiene

- Signs will be posted throughout the venue, and frequent announcements will be made, with reminders that you must be wearing a mask or facial covering, performing hand hygiene and maintaining social distancing requirements.
- Hand sanitizer stations will be dispersed throughout the venue.
- Those unable to wear a mask per CDC guidelines will be assigned seats in specific areas around the field.

# During the Game

- Each team will be assigned a game ball that will be sanitized before and after the game and as needed.
- Players and coaches must maintain social distancing requirements will on the sidelines (no huddles, etc.)
- Spectators are expected to remain seated maintaining 6ft social distancing requirements (except those in the same household). Any spectator not following the guidelines will be asked to leave the venue.
- No spectator, player, official, coach, or volunteer may huddle or congregate post-game.
- No concessions will be open at the venue. Spectators may bring small coolers for snacks/drinks.

## Post-Game

- All spectators are required to stay seated until dismissed by the announcer. Children may find their parent/guardian after the game and leave once dismissed.
- East (back) gates will be utilized for exits only. No entrances through these gates. There will exit gates open to the west (front) as well. The announcer will specify exit gates and volunteers will be present to ensure timely exits.
- A minimum of 2 hours will be provided for sanitization of each field and restrooms after a game.

#### Compliance

- For each game played at SHP, two compliance officers will be present monitoring social distancing requirements throughout the game. Any spectators violating the rules set forth will be asked to leave the venue.
- Volunteers will be used to assist and will be directed by compliance officers on policy and procedures before, during and after each game.
- CWPD will be monitoring games AT LEAST once per weekend.
