

## Legend SC Parental Agreement

Legend SC exists to support youth sports and provide a healthy environment for our youth to develop and grow. Legend SC believes the best youth sports environment is one of cooperation between Club and parents, creating lifelong memories and experiences as a club community to the benefit of our young players. We strive to assist your child in developing as a soccer player as well as supporting their physical and emotional development.

### AS A MEMBER OF LEGEND SC, I WILL:

- commit to enjoying the game of soccer and the opportunity my child has in participating in the sport.
- observe training from a distance in order to allow space for my child to focus on the best interaction with teammates and coaches.
- recognize that each coach will have his/her own style of coaching and communication all while upholding the Legend SC philosophies of play.
  - Some coaches may be more vocal during games or training, while other coaches may be more direct with one on one communication or even address topics during the next training session.
- pose questions for coaching staff in the proper manner and within appropriate times.
  - Legend SC maintains a “24 hour rule” after training or games for contacting coaches with questions, ideas, concerns with position play, etc. The “24 hour rule” is a good window for both parents and coaches.
- refrain from coaching from the sidelines and trust that my child’s coach is focused on developing and improving my child’s decision making process and soccer philosophy.
  - Please allow the coaching staff to communicate during games. It is our belief this helps the overall focus and decision making of the player. Legend SC places a high value on player’s decision making abilities and building player confidence in making the best decisions during game scenarios. Parents giving direction and coaching points from the sidelines can be a source of confusion and disruption for a youth player.
- avoid rewards and punishment based upon my child’s performance.
- encourage good nutrition, rest, and hydration for my player as this will assist in his/her preparation, health, recovery and overall well being.
  - Good nutritional habits will support them as they mature. Additionally, supporting good stretching and recovery habits will be a great tool for your young athlete (Rest, Ice, Compression, Elevation, etc).

- understand from time to time guest players will be utilized to help complete team numbers as well as challenge existing team members.
  - Guest player management is the sole discretion of the coaching staff and coaching director. Additionally, if your child is asked to guest play for another team, it is expected your family will fulfill their commitment to Legend SC events above guest playing for other teams. Guest playing should be presented to your coach 10 days in advance.
- be supportive to my child, the team, and the Club.
  - Conduct Standards
    - Parents should help contribute to the overall team environment and encouragement of their players. Please avoid lecturing your child pre and post game as this can be overwhelming. A player needs space to both prepare for games and decompress from games. Lecturing during these moments is often counterproductive. It is best to be supportive, assuring your child, pre and post game, that you are his/her biggest fan.
    - Youth sports should create good memories, good community and fun for all! We as adults are responsible for the Club environment created. Our behaviors and actions as adults represent Legend SC to our surrounding areas and the cities to which we travel. Please represent our club well and support the Legend brand!
    - Disrespectful behavior toward Legend SC players, opponents, opposing team parents, coaches and referees will not be tolerated. This is a Legend SC nonnegotiable.

Parents' actions shall at all times conform to the highest standards of good sportsmanship, good citizenship, and good moral conduct (CONDUCT STANDARDS). Parents shall not partake in any activity or act that, in Legend SC's sole and absolute discretion, may reasonably, in any way, injure or adversely reflect on the name, goodwill or reputation of Legend SC, its affiliated companies, or its products, logos, or trademarks (NEGATIVE ACTS). Use of the Legend logo or trademark to make shirts, headbands, socks and other apparel or products is not allowed.

Shall any parent/guardian either (a) fail to comply with any of the Conduct Standards, or (b) commit any of the Negative Acts, Legend SC, at its sole and absolute discretion, may remove the parent and his/her child from the program.
