    - 1. Is this a high use field? (Does this field have games, practice, classes and other school activities on it)
    - 2. Is it important for this field to look good year-round?
    - 3. Do we want to protect this field from excessive wear and erosion?
    - 4. Do we want a playing surface that can withstand traffic during the winter months?
    - 5. Do we want a playing surface that more dynamic and safer for sports?

#### 3. All-Pro's Message

Our goal is to provide you with a safe and eye pleasing athletic surface, by maintaining a turf that actively grows during our cool season, like rye grass. It's a simple fact that active growth holds up better than dormant grass (you may save thousands of dollars in sod & labor if the surface is overseeded) actively growing rye grass also provides a more dynamic, softer playing surface that's better and safer for sports than a dry dormant field. (Would your athletes like a more consistent ball roll?) Heavy traffic can impact a dormant playing surface, excessive wear can slow the regrowth of dormant Bermudagrass in the Spring. Excessive wear can create bare spots, erosion and increase the incidence of weeds. Consider these benefits as the fall season is around the corner. Overseeding is a smart choice that extends beyond just the look of your field.

#### g. Wetland Delineation Study

"It's still not a guarantee the BOCC would authorize developing the areas in question, but I know they wouldn't even consider the request without formal/professional identification of wetlands. Since the county does not necessarily have interest in developing these areas, we are not planning to pay for wetland studies.

If the studies are favorable and the BOCC wants to use the space for recreational amenities, I think a financial partnership of some sort would make sense at that time."

#### h. Cheer Tumbling

Cheer is looking to utilize our Wednesday gym time to start holding tumbling classes. These classes will be separate from cheer practices and will require a monthly fee. With all of the new equipment we ordered with our fundraising money we are excited to have the facility space, equipment needed, and have a certified tumbling instructor coming in to teach our athletes proper progressions and how to safely do skills. (Fundraising paid for the equipment to make this possible. Monthly fees are split between the tumbling coach and NYSA CHEER) Coaches are allowed to use the tumbling equipment during practices also, it is not just reserved for these classes. Here is what we are looking at:

Wednesday (Beginning Sept - End Nov 2025) 60 available slots

- 5:00pm-6:00pm Beginner/intermediate 6U-9U, twenty slots
- 6:00pm-7:00pm Beginner/intermediate 10U-14U, twenty slots
- -7:00pm-8:00pm Advanced All Ages (Pre Reg BHS), twenty slots

\$65 per month compared to neighboring facilities charging \$105+. This is an extremely affordable option and now we have the same equipment as the gyms down the road to help make our program successful!

Once the slots are filled, they will be waitlisted. Once we have kids that drop, the athlete waitlisted will be contacted to fill their slot.

I have been chatting and received resumes from coaches that are interested in working with our program. I am certified to coach tumbling; however I think it's important to get some new faces in to work with the girls. If need be, I will be there to assist if she needs help, but this will not be something I am taking lead on other than organizing and making sure everything is running smooth.

I think I have found the perfect coach. She has an approved background check, insured and has no problem adding NYSA to her policy, and most importantly is certified to instruct, CPR/AED Certified, and is even a NASM personal trainer.

I feel this is a good step for our program to ensure we are appropriately preparing our athletes for middle school select and also for the high school. These classes will be open to NYSA Cheerleading members ONLY. Currently we feel comfortable opening 60 slots and seeing how well that does. When basketball is over in Feb/March we are hoping to start again and do March/Nov 2026 and open more slots to accommodate our athletes. Registration slots will be a first come first serve basis. I would like to open them to coaches kids first because a lot of us are coaching or at the field 4-5 days a week and that leaves us little time to get our own kids into a tumbling program to help them progress. If this is frowned upon, I totally understand. I just want to advocate for my coaches since like every other NYSA coach/volunteer/board member, they donate a lot of their time to make our program special. So, I really hope we can make that possible for them.

Please let me know if this is okay to get to Jason and get registration started. We are wanting to have our first class start 9/3 and know these will fill up quick!

Also discussed issues with current umpire quality and possible solutions, including using high school players for lower age groups and developing an umpire/referee committee.
    - ii. Travel Baseball/Feeder Program report was presented by Coach John Crossley: Outlined the need for a developmental, competitive travel baseball program to serve as a feeder to the high school, emphasizing local player development and gradual growth.

#### b. Basketball:

i. Winter basketball season team reduction proposed by Otis Simmons. Suggested reducing from eight to six teams to improve quality and player retention

#### c. Cheerleading:

- Opening Registration for Cheer Comp. Comp season End of January. Santa Rosa County Championship (Gulf Breeze) Red Nose Reindeer, Jan 17, Biloxi. Extended season for 14U Jan – Apr.
- d. Flag Football No Update

#### f. Lacrosse:

i. Chris McCall emailed his report in Fall Registration ongoing. Approximately 90 players so far, including high school. Two tournaments this fall, October 19th (Mobile) and October 26th (Navarre). If the league no longer provides the robot to paint our field (possible), we may need to explore options of renting/contributing.

#### g. NUFC:

i. Sean Acosta – Season kicking off, Utilizing Main parks common area to practice. Will Open Soccer Complex on the 18<sup>th</sup>. Culver's fundraiser complete, proposing a telethon for future fundraising idea.

#### h. Rec Soccer:

i. Coach meeting next Monday 11 August practice start Aug 25<sup>th</sup>

#### i. Softball:

i. Suggested switching field one with another field for T-ball and softball convenience. Schedule meeting at Pace next week, Clinics with high school coaching team. Softball evaluations scheduled for August 12 and August 14, 2025, on fields one, four, and five.

#### i. T-ball:

i. Registration as of Monday evening had ~4 6U spots open till full. There are about 6 families on the "4.5U" waitlist. I am planning on activating this waitlist this week (if there are still open slots) in order to give these families predictability.

Registration is open until next Wednesday evening which is also the Coaches meeting from 6-7:30. Season will be 4 teams with ~50 players.

Planning on initiating the Shades fundraiser approved over the summer as the season starts (and families have to sit out and sweat).

Also will be getting quotes for electrical power outlets (30/50 AMP) and gate expansion to present to the board for next steps.

Looking to see if other sports or the NYSA at large wants to go in 'halfsies' on my previous initiative regarding the scoreboards previously mentioned. Each scoreboard ~\$2000k, looking for 2. Portable and multi-sport capable.

a. Concerns about Rec Baseball and Rec Softball needing to use the fields. Spoke with Lee. Initially said no, but changed to yes once it was explained to him that the request was for the Holley Field on Sunday August 10<sup>th</sup>. Rec Softball does not use the Holley Field

#### vii. New Business

- i. There will be 6 teams in each age group, with a maximum of 10 players. The girls' league could start on 1 November and end on 10 Jan, and the boys' league could start on 1 December and end on 21 Feb. The girls will practice and play at the YMCA, while the boys will practice and play at NYSA.
- ii. Practice schedule is tentatively 5-8, and games only on Saturdays
- iii. We have coordinated an agreement with the YMCA for field rental. The cost for the 9 weeks 74 hours over the season will be \$1000. Otis said he has the budget to cover the cost. The request to have YMCA's location added to our insurance has been made.
- iv. In return for such a good deal, the YMCA asked if they could use our fields to host games if their fields are flooded. Their games are played inside of their retention pond. During rain storms their fields will flood out and have no where to play. They would need half of a soccer field or two softball/baseball fields. Games are held on Saturdays.
  - 1. Softball, Football and Soccer fields have space and typically are available. Baseball and T-ball have games on Saturdays from 0800 until 2.
- v. If NYSA Basketball books a food truck, they would split the proceeds with the YMCA.

#### **Purpose**

To plan, organize, and execute two high-quality, inclusive, and financially successful youth sports tournaments annually for each of the following NYSA programs: Softball, Baseball, Soccer, Lacrosse, Basketball, Cheerleading, and Flag Football.

#### **Committee Structure**

- The committee will consist of at least one representative from each sport: Softball, Baseball, Soccer, Lacrosse, Basketball, Cheerleading, and Flag Football.
- A Tournament Committee Chair will be appointed or elected to lead and coordinate all committee activities with the Board of Directors
- Representatives will serve as liaisons between the Tournament Committee and their respective sport's commissioner, teams, and volunteers.

#### **Duties and Responsibilities**

#### 1. Strategic Planning and Scheduling

- Select and confirm annual tournament dates in coordination with sport commissioners and facility availability.
- Develop a multi-sport tournament calendar that minimizes overlap and maximizes participation.
- Establish timelines and planning milestones for each tournament.
- Partner with organizations to facilitate tournament (USA, USSA, Panhandle Basketball).

#### 2. Budgeting and Finance

- Prepare a detailed budget for each tournament including entry fees, officials, awards, concessions, security, and supplies.
- Coordinate with NYSA's Treasurer to manage income and expenses.
- Seek sponsorships and donations to offset costs and increase revenue.
- Ensure financial accountability through post-tournament reporting.

#### 3. Registration and Team Coordination

- Create and manage online registration systems.
- Communicate regularly with team representatives regarding rules, scheduling, and logistics.
- Coordinate tournament seeding, brackets, and scheduling using standardized tools.

#### 4. Venue and Logistics Management

- Reserve fields, gyms, and other facilities needed for each sport.
- Ensure proper setup and breakdown of tournament venues including signage, field preparation, and seating.
- - Coordinate parking, security, trash collection, restrooms, and emergency access.

#### **5. Staffing and Volunteer Coordination**

- Recruit, train, and assign volunteers for admissions, concessions, set-up/clean-up, scorekeeping, and hospitality.
- Work with sport commissioners to assign referees, umpires, and judges for each event.
- - Design and distribute volunteer schedules with point-of-contact details.

#### 6. Marketing and Promotion

- Create promotional materials (flyers, social media, emails) in collaboration with NYSA's communications team.
- - Engage local media and community groups to promote the tournaments.
- Highlight key players, teams, and sponsors before and after the event.

#### 7. Awards and Recognition

- - Plan for trophies, medals, and certificates for winning teams and individuals.
- - Coordinate sportsmanship and MVP recognitions with coaches and officials.
- Publicly acknowledge team successes and sponsor contributions.

#### 8. Compliance and Safety

- Ensure all tournaments follow NYSA policies, insurance requirements, and sportspecific rules.
- - Coordinate with medical staff/EMTs and develop an emergency response plan.
- Confirm all coaches and volunteers have required background checks.

#### 9. Evaluation and Reporting

- Conduct post-event debriefs to identify successes and improvement areas.
- Collect feedback from coaches, parents, and volunteers.
- Submit a tournament summary and financial report to the NYSA Board.





- Any change to the voting system must pass an internal security review before going live.
- All staff workstations are kept up-to-date and protected by access password, firewall, anti-virus, antispamware and disk encryption.
- We authenticate our emails with DomainKeys Identified Mail and the Sender Policy Framework to protect voters from phishing attacks.
- Our servers are protected by a very powerful firewall, FortiGate Unified Threat Management, which includes an Intrusion Detection System (IDS) and a redundant firewall on hot standby. Webservers are further protected by the ModSecurity Web Application Firewall (WAF).
- Network access is protected by a Virtual Private Network (VPN) and Two-Factor Authentication (2FA).
- Simply Voting uses an automated and always-on solution from Radware to protect against Denial of Service (DoS) attacks.
- We use redundant *Anycast DNS* deployments which protects against DNS-based DDoS attacks.
