In exchange for allowing my child to participate in this tournament, I/we hereby agree to hold harmless, release, discharge and/or otherwise indemnify the Petoskey Autumn Blast, Petoskey Youth Soccer Association, USYSA, City of Petoskey, Bear Creek Township, City of Petoskey schools, Emmet County, and Emmet County Board of Commissioners, the owners and caretakers of the fields and facilities used, and any and all involved officers, directors, agents, assigns, volunteers, and employees of such groups, from any liability, claims, or cause of action for injury, damage, or death. This hold harmless, release, discharge, and indemnification is on behalf of myself, the child's parents and/or guardians, and the participating child. I aver that I am the legal parent or guardian of the participating child and that I have full authority to agree to this Liability Release and Waiver on the child's behalf. All participating players' parents must sign this waiver for their child to be able to play.

- a. I agree that I and all other participants and/or persons in my family involved in any way in the youth soccer activities or events will fully comply with all federal, state and local ordinances, codes, rules, regulation, executive and/or emergency orders, and to strictly follow the protocols given the applicable governmental authorities, arising from, addressing or related to Covid-19 and/or any other threats to public health.

I agree that the releases, waivers and indemnities set forth above apply equally to any and all claims, loss, cost, damage and/or expense arising from or related to my or any participants, spectator's, or other person's failure to comply therewith or otherwise related to exposure during or in connection with the permitted youth soccer activity or event.
- c. I agree that effective physical distancing and proper hygiene can be only accomplished through personal responsibility and it is each person's individual duty to protect themselves their families and community, and doing so is the sole responsibility of myself, participant (if other than me), the other participants, and the other parties involved in the youth soccer activities or events, not the responsibility of the Petoskey Youth Soccer Association.
