

BAINBRIDGE ISLAND LITTLE LEAGUE ALL-STAR TEAM COMMITMENT

As a registered player in AAA and Majors in the 2026 season, your child will be considered to represent Bainbridge Island Little League as an All-Star in the District 2 and potentially other Little League tournaments.

Obviously not all players considered will be designated for the respective All-Star team roster. It is important to our league that all players under consideration for the All-Star teams fielded by Bainbridge Island Little League (BILL), as well as their families, have a complete understanding of, and are accepting of the commitments of time and potential travel required of our All-Star team players, families, and Manager/Coaches.

Please know there are no guarantees of playing time or playing position on the All-Star team.

These decisions are in the hands of the All-Star manager and coach. Undoubtedly, some kids who played most innings during the regular season may be asked to play a different role on the all-star team that involves fewer innings and fewer at bats. We would ask you to explain this to your child and make sure he or she understands and agrees to practice, play, or sit on the bench (wherever the team needs him or her) to the best of his or her ability. Of course, attending all practices and games is imperative.

Once the team has been selected, the All-Star team Manager will establish a practice schedule for his/her respective team. Prior to the conclusion of little league play on June 6th, the All-Stars Manager will likely hold limited additional practices as to not interfere with the existing LL practice/game schedule. However, BILL provides no direction as to the time or number of practices in which an All-Star team should participate prior to their first game but does provide the practice field. Your team Manager may elect to practice only once per day or more frequently (especially after regular season little league is over). They may decide to practice every day or to provide "off days" for the team. Each team Manager makes this decision independent of each other. It should also be expected that practices will occur between game dates throughout the respective tournaments until the All-Star team has been eliminated.

Teams will be announced in May and practices will begin on or about the week of May 15 at the discretion of the All-Stars manager.

The league feels strongly that all players must participate in virtually all team practices and games. **For this reason, BILL has drafted this agreement and requires every player and their parents to sign and acknowledge their availability and commitment to participate.**

PLAYER: I, the undersigned, understand that this is a contract between the coaching staff of the 2026 Bainbridge Island Little League All Star Team and myself. I understand that being on the team is a **privilege** and not a right. In order to maintain my status as an All Star, I understand that I will be required to attend all practices and games and be there on time. I further understand that I have no right to expect a certain amount of playing time. Playing time will be at the sole discretion of the manager and coaches. I also understand that I have no right to a particular playing position. Playing positions will be assigned at the sole discretion of the manager and coaches.

Whatever my role may be on the All-Star team, I agree to make all games and practices on time. I agree to practice, play, or sit on the bench (wherever my team needs me) to the best of my ability, and I

agree to always hustle. I understand the **"team concept"** and I agree always to put forth my best effort on behalf of the team. I will strive to encourage my team, and at all times I agree to maintain a positive attitude. I understand that I am a representative of Bainbridge Island Little League. I agree to represent the league and my team by being the best All Star I can possibly be.

I understand that I may be removed from the team by the manager or coaches if I am not able to fulfill this commitment.
