

RULES, REGULATIONS AND SANCTIONS

OF

PEARL RIVER SOCCER CLUB (P.R.S.C.)

The following conduct and discipline rules will apply to all activities sponsored by the Pearl River Soccer Club (PRSC).

1. Players Rules, Regulations and Sanctions

Rules and Regulations

- 1. There will be no tolerance of substance use and/or possession of (alcohol, and/or drugs) smoking is prohibited on the fields and venues that we play.
- 2. Treat ALL opponents, officials, supporters and spectators with proper respect.
- 3. Accept all coaching decisions during the game without question.
- 4. Treat ALL teammates and coaches with proper respect.
- 5. The usage of profane language on the field will not be tolerated.
- 6. No Violent conduct. Attempting to strike or striking another player or spectator.
- 7. Show a proper supportive attitude during all practices, pre-game preparations and games.
- 8. Harrasment of any type will not be tolerated, including sexual harassment.
- 9. Appropriate sports apparel is expected to be worn during soccer functions. Clothing not intended as sports apparel shall not be worn at soccer functions. Apparel that expresses foul language, insults, gang affiliation, or derogatory racial comments are not to be worn and are considered un-sportsman like behavior. Reasonable levels of modesty should be adhered to when choosing and wearing sports apparel at soccer club practices and matches. Shorts must cover undergarments (this is a FIFA law of the game) and female tops should cover and support as intended. Club team uniforms are to be worn at all scheduled and organized soccer matches.
- 10. There will be no destruction of PRSC property.
- 11. All players shall win with humility and lose with grace.
- 12. Always exhibit the most positive image possible, both on and off the field. Remember that you are not only representing yourself, but the Club and your team as well.

Sanctions

- 1. Substance use and/or possession of alcohol and/or drugs are cause for immediate dismissal from the team/club for the remainder of the season. No exceptions
- 2. First disrespectful (gestures or usage of profane language) offense towards officials, Coaches, Team Mates, Team Opponents, Supporters and Spectators, will be sanction by a verbal warning. Second disrespectful offense is cause for removal from the next game. Third disrespectful offense is cause for removal of two games and is subject to review by the Board of Director's Disciplinary Committee for final disciplinary action
- 3. Violent acts will be subject to review by the Board of Director's Disciplinary Committee for final disciplinary action.

- 4. Harassment or bullying other players, first offense will be sanction by a verbal warning, second offense is cause to sit the next game and coach and/or commissioner will speak with parents if the offender is a minor. Third offense will be subject to review by the Board of Director's Disciplinary Committee for final disciplinary action.
- 5. All sexual harassment offenses are subject to review and investigated by the Board of Director's Disciplinary Committee for final disciplinary action.
- 6. Destruction of any PRSC property is subject of monetary sanction to replace the broken equipment.

Note: No reimbursement of fees will be made due to the dismissal of a player from the club for violation of the above rules.
